



## Team & Player Entry Terms & Conditions

Terms and Conditions apply for the booking of a Team or Individual entry in any Amros Event Managed Golf Days at the specified venues, hereinafter referred to as 'The Golf Club' and the management services and associated merchandise provided by Amros Golf Event Management Ltd. hereinafter referred to as (AGEM). The following shall be subject to The Golf Club's sole discretion and their own Terms and Conditions (which are available upon request from AGEM where applicable). All costs are subject to VAT at the current rate.

### Golf Days

- 1/ All golf days, will comprise of a minimum of teams / players specified by client.
- 2/ All golf days will have a start time as agreed by the client.
- 3/ All corporate golf days will be a team competition and each team will consist of a maximum of 4 players.
- 4/ Scoring will be specified by the client.
- 5/ Handicaps allowances will be specified by the client.
- 6/ The scoring format of each golf day will be specified by the client.
- 7/ Referee's / Organiser's decision is final.

### Booking

- 8// To enter a team or Individual into any Amros Event Managed Golf Days, please go to the Events tab on the website and choose the required Event you wish to enter and follow the instructions to make your booking.
- 9/ Once your booking has been made, you will receive an email, with your booking confirmation & VAT invoice. Team player details request will be made 30 to 45 days prior to the respective date that has been booked.
- 10/ The Team / Individual entry fee is non-refundable.
- 11/ Team Captain or Individuals are to ensure that as the named entrant, your players adhere to the respective Golf Club's Codes of Conduct including dress codes (both on and off the course), course rules and buggy hire conditions. The named Team Captain / Individual will be held liable for any damage to the club, buggies & golf course which is caused by a team member.
- 12/ AGEM and The Golf Club accept no responsibility or liability for loss or damage to equipment or players. AGEM recommends that all individuals participating in The Golf Day take out golf insurance.

### Arrangements & Attending Players

- 13/ The Team Captain / Individual must confirm to AGEM all information required to organize & event manage the golf days when requested.
- 14/ Where the actual attendance of team / player numbers on the day is less than the amount booked, the proportion of the team entry fee is non-refundable.
- 15/ AGEM reserves the right to reallocate the golf event if the attendance differs significantly from the predicted number. AGEM will give written notice of any amendments prior to the event.

### Shot Gun Starts

- 16/ By agreement of AGEM & the Golf Club. A minimum of 72 players are required to obtain this format.

### Cancellation

- 17/ The Golf Club & AGEM may, at their sole discretion, cancel at any time any golf event, whilst providing as much notice as they can reasonably do so:
  - a) The Golf Club, or any part of it, is closed due to fire, natural disaster, employee dispute, alteration, demolition, decoration or Order of any Public Authority.
  - b) The team captain / Individual is more than 7 days in arrears with any payment due to The Golf Club or AGEM.
  - c) The team / Individual reservation is potentially detrimental to the reputation of The Golf Club or AGEM.
  - d) The Golf Club considers adverse weather prevents the playing of golf. In this event the club & AGEM will transfer any payments made in respect of the respective golf day and will re-schedule another date, but will have no further liability to the Client.
  - e) The Golf Club considers adverse weather prevents the completion of playing 18 holes of golf. In this event the club & AGEM will calculate the score on the amount of holes that all teams have played. There will be no refund for any loss of holes played.
  - f) Tee times may be altered due to partial closure of the course.
  - g) Frost holes may be utilized only where necessary to protect the course at the discretion of the clubs Director of Golf.
  - h) In the event that a team captain is found to have misrepresented their entry to any event, the Golf Club & AGEM reserves the right to cancel their participation without refund of monies paid.

### Payment

- 18/. The Golf Club & AGEM are not liable to offer reductions or reimbursement in the event that weather affects your golf day in any way whatsoever excluding section (17d). If golf course is closed due to bad weather, it will be re-scheduled without extra charge.
24. The team Captain / Individual agrees to take full responsibility and to reimburse the Golf Club & AGEM, for the cost of repair arising from any damage to the property, contents or course and grounds which is caused by a team member.
25. The team Captain / Individual agrees to pay any extras ordered on the day and the account will be settled on the day.
26. All prices quoted exclude VAT unless otherwise stated.
27. All Credit Card payments will be subject to a 2.75% fee.
