



Name

The Society shall be known as the West Midland Business Golf Society (WMBGS)

Management

Amros Golf Event Management Ltd. (Amros) will administer & manage all (WMBGS) events.

Membership

- 1) Corporate Membership, with nominated players that must be associated with Member Company.
- 2) Application form must have full details as requested for all nominated players.
- 3) Potential new members can only be invited by an existing member or by any Associated Chamber of Commerce.
- 4) New members after returning the completed application form & subscription fee will be considered for membership. Confirmation of election will be within 14 days from receipt of form & fee.
- 5) Guests after their second visit may be invited to join
- 6) All approved members are entitled to enter any (WMBGS) event as long as event fee is paid by required date.

Subscriptions

- 1) The (WMBGS) year shall commence on the 1st January and end 31st. December of each year.
- 2) The annual subscription amount shall be payable on election and thereafter on the 1st. January each year
- 3) Any member with subscription arrears, are not eligible to take part in any (WMBGS) event.
- 4) Any member with subscription arrears may be removed from the (WMBGS) membership list.
- 5) Membership subscription fee to be paid to (Amros)

Guests

- 1) All guests are the responsibility of the inviting member.
- 2) Members are responsible for payment of their guest's event fees.

AGM / Conference

All Members are invited to attend AGM & Annual Conference.

Competition

- 1) All (WMBGS) events shall be held at such times & under such conditions as (Amros) shall determine.
- 2) Handicaps - Ladies a maximum of 36 & Gentlemen a maximum of 28 which will be $\frac{3}{4}$ of the difference.
- 3) Individual events will be best stableford points.
- 4) Fourball team events will be best 2 from 4 stableford total points.
- 5) All competitions shall be governed by the rules of the Royal & Ancient Golf Club of St. Andrews and subject to local rules of the course over which the competition is played.
- 6) Decision of (Amros) is final.

Handicaps

- 1) All members are to hold a Club or Society handicap.
- 2) Members are to notify of any handicap changes to (Amros).
- 3) Society handicaps can be amended as seen fit by (Amros).
- 4) Winning individuals to have their Society handicap reduced by 2 shots for the next 2 (WMBGS) events they attend.

Sponsorship

- 1) All members are able to sponsor any available event at special member rates.
- 2) Full sponsorship packages available.

Booking

- 1) To enter as an individual or a team into any of the (WMBGS) events, please go to www.amrosgolf.co.uk website Course & Date section and chose the required Venue & Date that you wish to enter and follow the instructions to make your booking.
- 2) Once your booking has been made, you will receive an email, with your booking confirmation & VAT invoice.
- 3) For a team booking your player details request will be sent to you 45 days prior to the respective date that has been booked.
- 4) Final details for all (WMBGS) will be sent 14 days before respective booked event.
- 5) Entry fees are non-refundable.
- 6) Individual players & team captains are to ensure that as the named entrant, your players adhere to the respective Golf Club's Codes of Conduct including dress codes (both on and off the course), course rules and buggy hire conditions. The named entrant will be held liable for any damage to the club, buggies & golf course which is caused by a team member.
- 7) (Amros) and The Golf Club accept no responsibility or liability for loss or damage to equipment or players. (Amros) recommends that all individuals participating in The Golf Day take out golf insurance.
- 8) Where the actual attendance of individual or team numbers on the day is less than the amount booked, the proportion of the team entry fee is non-refundable.

Cancellation

The Golf Club & (Amros) may, at their sole discretion, cancel at any time any golf event, whilst providing as much notice as they can reasonably do so:

- a) The Golf Club, or any part of it, is closed due to fire, natural disaster, employee dispute, alteration, demolition, decoration or Order of any Public Authority.
- b) The entrant is more than 7 days in arrears with any payment due to The Golf Club or (Amros).
- c) The team or individual reservation is potentially detrimental to the reputation of The Golf Club or (Amros).
- d) The Golf Club considers adverse weather prevents the playing of golf. In this event the club & (Amros). will transfer any payments made in respect of the respective golf day and will re schedule another date, but will have no further liability to the Client.
- e) The Golf Club considers adverse weather prevents the completion of playing 18 holes of golf. In this event the club & (Amros). will calculate the score on the amount of holes that all teams have played. There will be no refund for any loss of holes played.
- f) Tee times may be altered due to partial closure of the course.
- g) Frost holes may be utilized only where necessary to protect the course at the discretion of the clubs Director of Golf.
- h) In the event that a individual or team captain is found to have misrepresented their entry to any event, the Golf Club & (Amros). reserves the right to cancel their participation without refund of monies paid.

Payments

- a) The Golf Club & (Amros) are not liable to offer reductions or reimbursement in the event that weather affects your golf day in any way whatsoever excluding section (cancelled d). If golf course is closed due to bad weather, it will be re scheduled without extra charge.
- b) The individual or team captain agrees to take full responsibility and to reimburse the Golf Club & (Amros), for the cost of repair arising from any damage to the property, contents or course and grounds which is caused by a team member.
- c) The individual or team captain agrees to pay any extras ordered on the day and the account will be settled on the day.
- d) All prices quoted exclude VAT unless otherwise stated.
- e) All Credit Card payments will be subject to a 2.75% fee.
